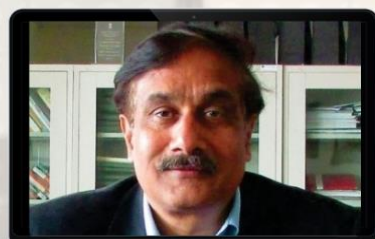

Dr. M. S. Sahoo, Chairperson, IBBI is appointed as the new Hony. Chairman, FOIR on 1.10.2020

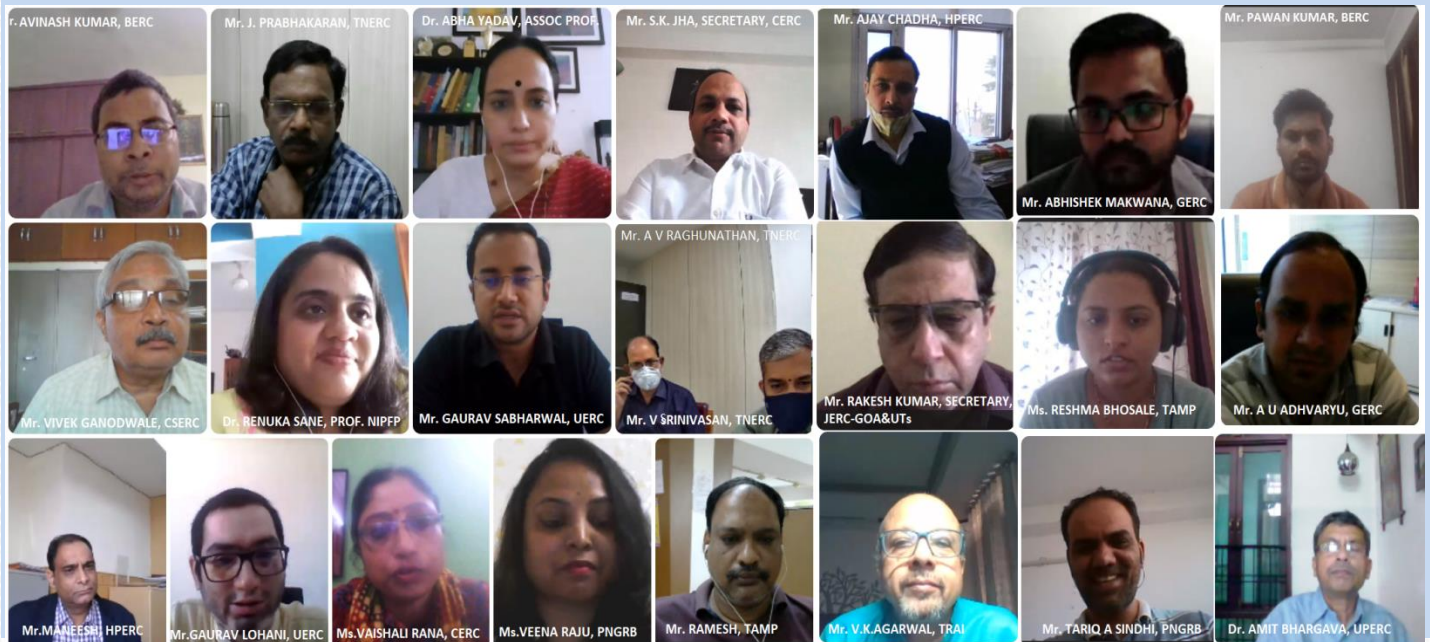
